#### REFERENCE

The Hon. Minister of Labour and Social Security, by letter dated January 6, 2022, Ref. No. A5643/S3, has referred to the Industrial Disputes Tribunal ("the Tribunal") for settlement the dispute between **Jamaica Money Market Brokers Limited** and **Mrs. Amoy Melhado-Pandohie** in accordance with Section 11A (1)(a)(i) of the Labour Relations and Industrial Disputes Act, 1975 ("the Act"), with the following Terms of Reference:

"To determine and settle the dispute between Jamaica Money Market Brokers Limited on the one hand, and Mrs. Amoy Melhado-Pandohie on the other hand, over the termination of her employment".

#### **SUBMISSIONS AND SITTINGS**

1. At the first sitting on May 6, 2022, both parties acknowledged the exchange of briefs and were <u>ad idem</u> with the terms of reference. Mr. Duncan expressed the view that the parties were in dialogue about reaching a settlement and believed that with greater effort this could be achieved. Ms. Robertson concurred and said that she will seek further instructions from the company.



2. The parties nevertheless agreed to commence proceedings with counsel for the company making her opening submission to include a number of exhibits on which both parties had agreed. The company's first witness was Miss Simone Dunbar, Human Resource Administration Manger. At the 11th sitting held on November 2, 2022, counsel had completed her examination-in-chief and Miss Dunbar was being cross-examined by Mr. Duncan.

#### **PARTIES' RESPONSE**

- 3. By letter dated March 3, 2023, counsel for the company wrote to the Tribunal advising that a settlement has been reached, and attached a joint letter dated February 6, 2023 duly signed by the respective representatives.
- 4. The letter of February 6, jointly signed by both parties, informed the Tribunal that "... the dispute between Jamaica Money Market Brokers Limited and Mrs. Amoy Melhado-Pandohie over the termination of her contract of employment has been settled, the terms and conditions of which are confidential," and requested the Tribunal to schedule no more sittings on this matter.





#### **AWARD**

5. The duly executed letter of February 6, 2023, herein attached, reflects the full participation of both parties in a settlement agreement, the terms of which have not been disclosed to the Tribunal. Accordingly, the Tribunal will discontinue proceedings and record the settlement in the form of an award.
