The Hon. Minister of Labour and Social Security, by letter dated August 29, 2024, has referred to the Industrial Disputes Tribunal ("the Tribunal") for settlement the dispute between **Minott Equipment & Chemicals Limited** and **Adrian Vanwhervin** in accordance with Section 11A (1)(a)(i) of the Labour Relations and Industrial Disputes Act, 1975 ("the Act"), with the following Terms of Reference:

"To determine and settle the dispute between Minott Equipment & Chemicals Limited on the one hand, and Adrian Vanwhervin on the other hand, over the termination of his employment."

SUBMISSIONS AND SITTINGS

- 1. The Tribunal received Briefs from both parties outlining the salient issues in respect of their cases. At the first sitting held on November 19, 2024, the Company made its Opening Submission, setting out the circumstances surrounding its decision to terminate the services of Mr. Vanwhervin. Counsel for the Company, however, indicated their willingness to re-engage in another mediation session with the representative of the Aggrieved Worker. Mrs. Gallier, on behalf of the Aggrieved Worker, in an email to the Tribunal dated January 23, 2025, confirmed that her client would be open to mediation with the assistance of the Tribunal.
- 2. At the third sitting held on January 29, 2025, the parties were advised that Tribunal Member, Mr. Paul Hines would facilitate the discussions and report back to the Panel as quickly as possible on the status of the mediation.



PARTIES' RESPONSE

3. On February 26, 2025, Mrs. Laura Williams-Gallier, Industrial Relations Consultant at Prime Employee Advisors, representing Mr. Vanwhervin, advised the Tribunal by email that the matter between her client and Minott Equipment & Chemicals Limited has been settled. On February 28, 2025, the Tribunal then wrote to Ms. Ashley Mair from Mayhew Law, the Attorney representing the Company informing her of the email from Mrs. Gallier. By letter dated March 19, 2025, Ms. Symone Mayhew, KC, confirmed that the matter has been settled between the parties.

AWARD

4. The email of February 26, 2025 and the letter of March 19, 2025, herein attached, reflect the full participation of both parties in a settlement agreement. Accordingly, the Tribunal will discontinue proceedings and record the settlement in the form of an Award.


