By letter dated April 8, 2025, the Honourable Minister of Labour and Social Security pursuant to Section 11A(1)(a)(i) of the Labour Relations and Industrial Disputes Act (hereinafter called “the Act”), referred to the Industrial Disputes Tribunal for settlement in accordance with the following Terms of Reference, the industrial dispute described therein:-

The Terms of Reference was as follows:

“To determine and settle the dispute between Teams HGS Limited (t/a Hinduja Global Solutions) on the one hand, and the Keno Reid on the other hand, over the termination of his employment.”

SUBMISSIONS AND SITTINGS:

1. Briefs were submitted by both parties and five (5) sittings were held between July 10, 2025 and October 14, 2025. During this period, the Chairman actively encouraged the parties to try and resolve the matter at the local level.
2. At the 5th sitting held on October 14, 2025, the Tribunal was formally informed by the parties that they had reached a settlement and would be submitting a joint letter confirming the terms.

REPORT TO THE TRIBUNAL:

3. On December 1, 2025, the Tribunal received a joint letter from the parties dated November 28, 2025, confirming that the dispute has been settled.

AWARD:

4. The parties having settled the dispute at the local level without the assistance of the Tribunal have by way of joint letter dated November 28, 2025 (a copy of which is attached) informed the Tribunal of the settlement. It is that settlement which constitutes the Award.




