**REFERENCE:**

By letter dated April 7, 2025, the Honourable Minister of Labour and Social Security in accordance with Section 11A(1)(a)(i) of the Labour Relations and Industrial Disputes Act (hereinafter called "the Act"), referred to the Industrial Disputes Tribunal for settlement in accordance with the following Terms of Reference, the industrial dispute described therein:-

The Terms of Reference was as follows:

*"To determine and settle the dispute between Ultra Medical Services Limited on the one hand, and Muriel Bolton on the other hand, over the termination of her employment."*

## SUBMISSIONS AND SITTINGS:

1. Briefs were submitted by both parties and two (2) sittings held on June 26, 2025.
2. At the 2<sup>nd</sup> sitting of the Tribunal, the parties were encouraged to have discussions to see whether they could arrive at a settlement. The Chairman suggested that a Tribunal Member, not currently involved in the matter, could facilitate conciliation between the parties. This proposal was accepted by both parties. Contingency hearing dates of September 22, 23, and 29, 2025, were scheduled to resume the hearing of the dispute should conciliation efforts prove unsuccessful.
3. In accordance with the provisions of Section 12 (5) (b) of the Labour Relations and Industrial Disputes Act (LRIDA):

*"Notwithstanding anything to the contrary, where any industrial dispute has been referred to the Tribunal-*

*(b) it may at any time after such reference encourage the parties to endeavour to settle the dispute by negotiation or conciliation and, if they agree to do so, may assist them in their attempt to do so;"*

4. The Tribunal conciliated the dispute which resulted in an agreement being reached by both parties. The agreement forms the basis for this Award.


**AWARD:**






Please be advised that the mentioned dispute was settled at the local level


A settlement agreement was executed between the parties on September 5, 2025.
